 Also you will need to make a payment of 10% of your max bid or minimum of \$400.00 as a refundable security deposit. Security deposit is refundable at the end of the transaction. End of transaction is when you receive all the original documents on hand and the refund is processed only when you request for a refund via email to us.

FEES: (PAYMENT FOR THE FULL AMOUNT IS NOW DUE BY 24 HOURS FROM WINNING OF THE PURCHASE)

When you win a vehicle, Copart.com will charge you their fees after the winning bid amount.

M-97 Auto Parts charges the following fees after the final purchase amount from Copart.com:

You cannot use your security deposit towards your vehicle purchase; vehicle must be paid in full by wire transfer or bank deposit. Please note that wire transfer for most banks take longer. **The amount should be visible in our account for us to pay the vehicle off at the auction.**

A deposit will be required for this. However, M-97 Auto Parts will not be responsible for the transportation, the customer is still responsible for the pickup of their vehicle.
